
**Prefac**



## Lecturers



Prof. Ruth Wedgewood

Ruth Wedgewood is Edward B. Burling Professor of International Law and Diplomacy, Johns Hopkins University. She served on the US Secretary of State's advisory committees on private and public international law and on the CIA historical review panel: US delegate to the UN Human Rights Committee (Geneva and New York, 2003-11); was independent expert for UN criminal tribunal for the former Yugoslavia; former director of studies at Hague Academy for International Law, and tenured professor at Yale Law School: named Berlin Prize Fellow of the American Academy; was vice president of the American Society of International Law, and is on the board of editors for American Journal of International Law, Journal of Strategic Studies, American Interest, World Policy Journal, National Defense University Prism and National Interest.



H.E. Judge Abdulqawi A. Yusuf

H.E. Judge Abdulqawi A. Yusuf is the President of the International Court of Justice, The Hague, The Netherlands. He was elected as Judge to the Court in November 2008 and re-elected in November 2017. He was Vice-President of the Court from 6 February 2015 to 6 February 2018. He is a member of the Institut de Droit International, a former chief legal counsel to various intergovernmental organizations, including UNESCO and UNIDO. He is the founder of the African Institute of International Law (AIIL), Arusha, Tanzania and of the African Yearbook of International Law. He is the author of numerous publications on various aspects of international law. He holds a Ph.D. in international law from the IUHEI, Geneva.



Prof. Laurence Boisson de Chazournes

Laurence Boisson de Chazournes has been professor in international law and international organization at the Faculty of Law of the University of Geneva since 1999. She is Co-Director of Center of International Dispute Settlement (CIDS) and Director of the Master in International Dispute Settlement (MIDS) since 2018. She has been invited as guest lecturer in numerous universities all over the world. She is an adviser to various international organizations (UN, ILO, WHO), governments and law firms. In the area of dispute settlement, Laurence Boisson de Chazournes has served as chairperson of WTO arbitration panels on pre-shipment inspections, has pleaded before the International Court of Justice (ICJ) and has been an arbitrator in investment arbitration (ICSID, ICC, PCA). She is a member of the Permanent Court of Arbitration (PCA) and of the Court of Arbitration for Sport (CAS) in which she has also been appointed arbitrator. She is an Associate Member of the *Institute of International Law.* 



Prof. Shinya Murase

Shinya Murase is Emeritus Professor of Sophia University in Tokyo, and currently visiting professor at Peking University. He obtained S.J.D. from the University of Tokyo in 1972. He was visiting scholar/research fellow at Harvard Law School in 1974-76, and visiting professor at Columbia Law School in 1995. He is a Member of the UN International Law Commission (ILC) since 2009 and its Special Rapporteur for the topic on the Protection of the Atmosphere since 2013. He is also Member of the Permanent Court of Arbitration (PCA). His association with academic institutions includes: Member of the Curatorium of the Hague Academy of International Law in 2004-2016 and Member of the Institut de droit international (IDI) since 2011. His major publications include: International Law: An Integrative Perspective on Transboundary Issues, Sophia University Press, 2011 (in English) and International Lawmaking, 2002 (in Japanese, Chinese translation published by the Chinese People's Public Safety University Press in 2012).



Prof. Leila Nadya Sadat

Leila Nadya Sadat is the James Carr Professor of International Criminal Law and Director of the Whitney R. Harris World Law Institute, Washington University in St. Louis. She currently serves as Special Adviser on Crimes Against Humanity to the International Criminal Court Prosecutor. She is an internationally recognized authority and prolific scholar writing in the fields of public international law, international criminal law, human rights and foreign affairs, and has published more than 100 books and articles in leading journals, academic presses, and media outlets throughout the world. She recently received an Honorary Doctorate from Northwestern University and the Arthur Holly Compton Distinguished Faculty award from Washington University, She held the Alexis de Tocqueville Distinguished Fulbright Chair in Paris, France in spring 2011, and is the Director of the Crimes Against Humanity Initiative, a ground-breaking project to write the world's first global treaty on crimes against humanity. She is the President of the International Law Association (American Branch) and a member of the U.S. Council on Foreign Relations.



Prof. Li Shiguang

Dr. Li Shiguang worked for the United Nations Secretariat from 1967 to 1998 where he handled legal and policy issues of environmental law, treaty-making, human rights, law of the sea, international humanitarian law, and settlement of disputes. He also trained legal advisers and diplomats in multilateral negotiation. He was the Executive Secretary for the United Nations Diplomatic Conference on the Establishment of an International Criminal Court; Director of the Legal Office for the codification and development of international law; Secretary of the International Law Commission; and Secretary of the Sixth (Legal) Committee of the General Assembly. He taught international and environmental law as a professor (adjunct) at Columbia Law School (1997 and 2014) and Yale University School of Forestry and Environmental Studies (2007-2018) and had been visiting professor or given lectures at different universities and academic institutions worldwide. He has published and edited nine books and some thirty articles on various topics and issues of international law.



Prof. Anthea Roberts

Anthea Roberts is a Professor in the School of Regulation and Global Governance (RegNet) at the Australian National University. She is a specialist in public international law, investment treaty law and arbitration, and comparative international law. She is also currently a visiting professor on the Masters of International Dispute Settlement at the Graduate Institute/University of Geneva. In 2017-18, she served as one of the two inaugural Legal Fellows for the Australian Department of Foreign Affairs and Trade as part of their new Diplomatic Academy. Her book "Is International Law International?" was awarded the American Society of International Law's 2018 Book Prize for the preeminent contribution to creative scholarship and has been Oxford University Press's top-selling law monograph worldwide in 2017-18. She has also twice won the Francis Deák Prize for the best AJIL article by a younger scholar, serves as a Reporter for the Restatement (Fourth) of the Foreign Relations Law of the United States, and has experience serving as an arbitrator, counsel, and expert in international disputes.



#### ▲ General Information

- 1. The closing date of application for admission is 30 April 2019.
- 2. Applicants to Xiamen Academy should be:
- (1) law students; or
- (2) teachers, lawyers or officials, etc. with at least a bachelor's degree; and
- (3) fluent in English.
- The admission office of Xiamen Academy retains the right to require applicants to supply related documents or certificates to show their qualification or competency.
- 4. Admissions are granted on the basis of academic criteria. All applicants are required to fill out the registration form (available on the Academy's website) clearly and completely, with accurate and truthful information.

#### Other Information

- 1. Visa Application: attendees shall bear the costs for obtaining a China entry visa. Xiamen Academy may provide necessary assistance to facilitate the attendees' visa application.
- 2. If applicants intend to apply for a scholarship, please make clear the type of scholarship you intend to apply in the application documents.
- 3. Attendees are responsible for their accommodation in Xiamen. If possible, Xiamen Academy will provide relevant information.
- 4. If there are any questions, applicants are free to contact the Academy via email.

#### Application Documents Checklist

Application Document Checklist (to be submitted via email - only electronic submissions will be accepted):

- 1. A registration form;
- 2. Two letters of recommendation from two professors of international law (sent by the referee directly to the Academy via email);
- 3. A curriculum vitae;
- 4. A certified copy of your examination certificates OR list of the courses that you have taken in international law (private and public), with the number of credits and your results, issued by your university (please send the scanned copy via email). If this is not possible please do so yourself and certify on your honour.



## **Scholarsh**

## Types and Eligibility for Scholarships

- Subject to the Regulations for Obtaining Scholarships, Xiamen Academy provides a limited number of scholarships to qualified applicants based on financial need and merit, as set out in section 4.
- 2. Xiamen Academy offers two types of scholarships:
- 2.1. A-type scholarship includes:
- (1) Full exemption of the registration fee;
- (2) A limited subsidy for the trip to and from the recipient's city to Xiamen:
- a. USD 400 for recipients from Asian countries (excluding recipients from China), or
- b. USD 600 for recipients from non-Asian countries, or
- c. Full reimbursement of round-trip hard-seat train tickets for recipients from Mainland China, or
- d. Reimbursement of travel expenses up to USD 200 for recipients from Hong Kong SAR, Macau SAR and Chinese Taipei.
- 2.2. B-type scholarship includes full exemption of the registration fee.
- 3. Selected participants will receive their scholarships during the Summer Programme. However, scholarship recipients must attend for the full duration of the summer programme. Failure to do so will result in the forfeiture of the scholarship in full, requiring a full refund of the scholarship by the disqualified recipient.



- 4. Scholarships are granted mainly based upon consideration of academic performance and financial status, among other factors. The country of origin of the applicants will also be taken into consideration to promote a balanced representation of participants from different countries. For Chinese Mainland applicants, the granting of scholarship is solely based on financial need. Therefore, a certificate of financial status must be submitted to prove the financial status of the applicant. This certificate may be issued by the applicant's university or local authority. Before applying for the Academy's scholarship, applicants are encouraged to exhaust other possible means of financial assistance and it is recommended that applicants also consult their own universities and institutions regarding financial assistance.
- 5. Application for scholarship shall be submitted in a separate document indicating the type of scholarship. Applicants could submit any additional documents they consider helpful to demonstrate their academic ability and financial status.

## Scholarship Regulations

### Regulations for Obtaining Scholarships

#### **Article 1**

Each year, Xiamen Academy makes available a series of scholarships which are awarded on the considerations of academic performance, financial status and the country of origin, among other factors.

#### Article 2

Scholarship recipients must comply with the provisions of these regulations concerning their obligations.

#### **Article 3**

Application for scholarship must be sent via email together with the application for admission and with any supporting documents, if available. All applications for scholarships must be received by the Secretariat no later than 30 April 2019.

#### Article 4

The Curatorium examines all applications received before the deadline. It establishes a list of scholarship recipients, and is in no way bound by any recommendation that it receives.

#### **Article 5**

Scholarship recipients will be notified of the Curatorium's decision during the month of May.

#### Article 6

The amount of the scholarship is paid by the Academy to each recipient during the period of summer programme.

#### **Article 7**

Scholarship recipients must attend for the full duration of the summer programme.

#### **Article 8**

Any failure by a scholarship recipient to comply with the obligations will have their scholarship revoked in full. Furthermore, the Academy reserves the right to demand the reimbursement of sums already paid to the recipient.
